ARTICLE 5 – DECLARATIONS OF THE PROVIDER

5.1 Accuracy and reliability of information submitted

The undersigned agrees that the information provided in the bid may be audited by the Council of Europe or verified by any means.

The undersigned undertakes to update Council of Europe with significant information changes within a reasonable time. Significant information changes include, but are not limited to change of legal status, ownership, name and address, loss of license of registration, filing bankruptcy, suspension or debarment by any national or local governmental agency or assimilated.

The undersigned agrees that failure to provide accurate and reliable information required by this Act of Engagement may result to exclusion of the bid from the tendering procedure and/or terminating all contracts signed as a result of the tendering procedure.

5.2 Exclusion criteria

The undersigned, declare that the Provider:

- has not been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering;
- is not in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or subject to a procedure of the same kind;
- has not received a judgment with res judicata force, finding an offence that affects its professional integrity
 or serious professional misconduct;
- does comply with its obligations as regards payment of social security contributions, taxes and dues, according to its applicable statutory provisions.

ARTICLE 6 – DOCUMENTS TO BE SUBMITTED

The Provider declares being informed that its bid will only be assessed if it contains the following documents:

- **Two completed and signed copies** of the Act of Engagement;
- ➤ A brief description of previous assignments carried out in the subject areas covered by the contract, indicating the objectives, summary of activities undertaken, amount, date and recipient;
- At least 3 (three) final reports of comparable evaluations recently carried out;
- > Contact details of references expected to support claims of knowledge, skills and experience;
- ➤ Registration documents and a brief profile description (preferably not longer than one A4 page), including the description of the nature of business, field of expertise, licenses, certifications, accreditations;
- > A **technical proposal**, including:
 - o CV(s) of person(s) in charge of the execution of the contract;
 - Evaluation Plan and Approach (preferably between 10 and 30 pages), see details in the Tender Rules.
 - In case of an evaluation team, describe also the roles and responsibilities of each evaluator; demonstrate convincingly that they have the ability to undertake evaluations and evaluation-related assignments in a context comparable to that of the Council of Europe;
- > The table of fees, duly completed (See Appendix to the Act of Engagement). Tenders proposing <u>at least one</u> fee above the exclusion level indicated in the Table of fees will be <u>entirely and automatically</u> excluded from the tender procedure.
